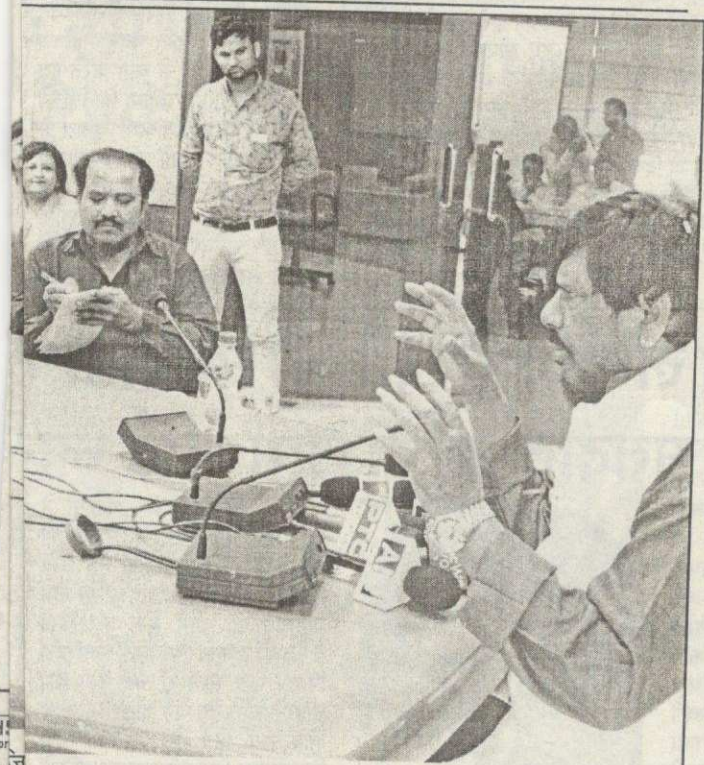

लखनऊ, 30 अक्टूबर। उत्तर प्रदेश की राजधानी लखनऊ में सोमवार को गोमती नगर क्षेत्र में बेखौफ बदमाशों ने दिन दिहाड़े एक गैस एजेंसी के कैशियर को गोली मारकर हत्या कर दी। वहीं अब प्रदेश के मुख्यमंत्री योगी आदित्यनाथ ने मृतक के परिजनों को 5 लाख रुपए की मदद का ऐलान किया है। बता दें कि सोमवार मोटरसाइकिल सवार बदमाशों ने गोमतीनगर में बैंक ऑफ इंडिया के सामने उर्दू एकेडमी रोड पर बिहारी गैस एजेंसी के कैशियर श्याम सिंह की गोली मारकर हत्या कर दी थी। वह गैस एजेंसी का 10 लाख रुपया बैग में रखकर बैंक में जमा कराने जा रहे थे। भीड़ भरे इलाके में करीब 10:30 बजे गोली मारकर लूट की घटना से लोगों में दहशत फैल गई। कैशियर श्याम सिंह गोली लगने के बाद गंभीर रूप से घायल हो गए थे। लोहिया अस्पताल में उन्होंने दम तोड़ दिया।
